The owner of the webmaster that's carrying this internet link; [www.wikiscams.com](http://www.wikiscams.com) is that notorious rogue website posting those stolen State Department and Department of Defense (DoD) or Pentagon stolen documents of the Federal Government of the United States of America (USA) that has no known fixed address and, is located outside the continental USA, and thus outside the reach of the law enforcement agencies of USA government.

3. Ever since I discovered this defamatory and slanderous internet link appearing in the Google search results every time I, or anybody else conducted internet search of my name: OMAR MMUBANGO I have desperately been trying to get Google to removed and permanently block this page from its active database or search results without success. Finally as an act of desperation and last resort I contacted attorneys that

specialize in the internet and other online social media deformation and slanderous litigation who advised me that, since this site has no fixed address and is located outside continental USA that there's absolutely nothing I can do legally to stop the webmaster that's responsible and the source of this offending internet link. But they did advise me to contact Google, Inc, since without the help of Google, Inc. as a principal carrier or prime facilitator—or aiding and abetting this link would not be able to appear on internet. So after researching Google website for the procedures for REMOVING entire link from its current and active database and search results, together with the e-mails that I continue to exchange with Google, Inc., we have arrive at two options, namely; (1) the first line of action is to contact the owner or the webmaster (www.wikiscam.com) and ask him or her to remove this link from internet and Google search engine. and if he or she refuses, then I can take legal action. Well this option is not applicable to me since this webmaster has no fixed address and is located outside continental USA. Option (2) To file a complaint against this anonymous party(s) and name Google, Incorporated as co-defender and then get a judgment and order, and then send a copy of that order to the Google, Inc., Legal Department directing Google to remove this slanderous link from its search results and Search Optimization Engine (SEO), since failing to obey a court order, Google, Inc., could be held legally liable for Deformation and Slander and monetary damages, etc.— and that's why I am seeking judgment and court order to send to Google, Inc. which it demands

4. Sadly enough this defamatory and slanderous conduct started happening just about the time I had been laid-off from job as a pharmaceutical chemist with a major
