District Court:

Civil Case:

I am righting you as among other things I did receive three speeding tickets in Utah in a week's period. If you remember, the office staff was unable to bring it up on the web or the computer. I thank the park city court for seeing me and not allowing a snafu to turn into a warrant. Let me also say, that I am 44 and I off all people realize that I cannot go back or undue history, but I wish to move forward. I have reason to believe, that over the years, my family and especially me may have been the victim of electronic surveillance such as wire taps on land and cell phone's, especially 65 Easton Lane Moreland Hills Ohio. Email, cell phone location, credit card and physical surveillance. I have made several inquiries, and the evasiveness and failure to respond from such high level people as governors and senators indicates that there is credibility to these claims. I am aware that this could be anyone from a neighbor who has my email password, to someone somewhere on a law enforcement or government

payroll who is out of line, to foreign government screwing around on a large scale. I have no idea. It is what it is. The improper use of this information, as well as improper orders by people seen as senior to me in my place of work, business or schools has done me harm. I'm 44, know very few people, and am not with any one at the moment. I was with JP Morgan for 7 years. It was clear that my immediate supervisors didn't want me socializing with people in the office, and I believe that women in New York were told not to see me as it might affect their position with the firm. Rumors were also spread around the office that I did not have a college degree, which is not true. There has been a long history of this behavior surrounding me. If you need more information, I would be happy to elaborate. I believe that you will find special files documenting this.

I am not as much interested in knowing what did this, but how to move forward. I believe that each of the organizations that this happened in is liable civilly for allowing this to happen. JP Morgan, Google, Verizon, Facebook, and Microsoft are all very large publically traded companies. It would be very easy for them to issue stock/options in an amount of 200-300 million without diluting the float. Also, I believe that the state of Montana, Gallatin County, Bozeman Deconies hospital, state of Ohio, Cuyahoga county are also liable.

Could you also please investigate my exact legal state. I was born in Ohio, I believe I may have been upgraded to employee of an intelligence agency, possibly NSA for legal purposes. My understanding is that it is illegal to release names or pictures of these people publicly. If this has been done, could someone brief me on any other rights/issues that are involved with this. Can I also claim diplomatic immunity? Can someone explain the intricacies of this if this status has been granted.

For the purposes of health care claim veteran benefits. I have been milked several times, the long term effects are unknown. Could someone point me to a DR that would be able to assess this. As far back as 93-95 I was dragged into a Cleveland Hospital, without a signature or a lawyer or any court room, large quantities of injectable psychiatric drugs were administered, without any formal police investigation. I have remained on this class of drugs until several years ago. This may have been necessary, and I do realize that these are FDA approved medications administered by trained MD's. They are hard stuff, the effects while on them are not exactly pleasant. I'd be curious to know if there are any long lasting effects.

There have been big, casually dressed people staked out at my Big Sky post office when I returned from a vacation, possibly from the result of obtaining my travel itinerary. I don't think he was sure I was the person he was looking for, I was not driving my convertible. I realize that this could happen again in the future. Can you let me know if and how I can identify myself as active duty military, or law enforcement for the purposes of carrying a concealed weapon. I would like to avoid confrontation or charges from police, but under the circumstances, it might be nice to be able to carry concealed if I thought something might happen.

Also, it would be nice to have some kind of number to someone in government, that could help with special security problems, and provide information of where to locate in the USA. I like to ski, but if say

Wyoming or Colorado would be a better place to be under the circumstances rather than Park City, it would be helpful to know this.

I realize that I'm 44, and events might catch up with me at a later date. If my health returns, I might at some point be interested in working again, possibly for a government agency. If nothing else than to get away from waitresses and lift operators.

Please let me bring to your attention I have submitted two complaint to the Montana Medical review board. They allegedly reviewed them, behind my back and came to some ruling without me even behind allowed to hear who or what was presented to the panel. The transcripts of the hearings have been destroyed, fabricated or not reviewable buy me or an independent court. I noticed that the Gallatin county sheriff and the CEO of Bozeman Hospital retired around the times off these hearings. I wonder if there is any connection to these events. I get a stone wall. I have also made several complaints to local laws enforcements about vandalizimin etc that occurred on my property. The officer has repeatedly refused to get back to me. And had refused to respond as what steps have been taken to investigate or put a stop to this. He has simply done nothing. I have complained to the undersheriff about this. He simply does not respond in any detail.

Some one opened a face book account in my name. My address book was mined. I did try to report this and several other computer related crimes to local Vegas police. My credit cards were used fragelently and canceled 4-5 times etc. These all went uninvestigated . I have received packages and emails that were obviously fictitious. They were obvious lures to receive my name and address. These have finally stopped. I have also been surrounded bye many older people, such as lawyers, and a retired doctor I met in Rotary. I have been sleared publicly and accused of being a Madof without ever being accused off a crime or a day court. I have also been told informally that I should not use my property bye this smart as retired doctor. It is my belief that some people have made statements to some type off law enforcement entity which have done me harm. I believe that they are fact less. If you could assist in finding them, it would be further basis for the suite. I would be happy to provide further details. I have approached the local Agencies, such as Montana State attorney general office, Governor's office, Galatian county sheriff. They have simply refused to respond and I have never gotten buy there secretaries. I am not sure why this is. I have no criminal record worse than traffic tickets. If they have penciled something in, or presented a different Pearson records to justify this, this would provide further marred for a suite. People especially refuse to schedule appointments and respond when I use email. This would be an easy question to ask Google and Microsoft.

Could you point me in the right direction to answer these question? I would be happy to be available to any one hear, in Utah, either on the phone or in person. I do have some savings, but will shortly run out. I believe that this is the hope off many people.

Judge. At this point, I believe local DC law enforcement would like a court order to be compelled to investigate. I am available, I do have some money for my own counsel, and would be happy to provide any more detail or direction on where to look for records or on how to proceed.

I would like to note, that all Jobs interviews have vaporized as if there were something derogatory or as if someone has told people that I am the subject off an on going investigation. I am aware of nothing. I have been sent a letter from a lawyer on a minor issue to one off my email that came back returned to sender because it was addressed to a physically different address. The lawyer refused to tell me where she got the email from. I have continually been put next to a single older person, in plain close that is my friend. If he is fishing or made statement based on his title as DR or Rotary member to any official agency, like judges, fbi, police etc. I would like to know about this. I have not been formally approached or served. This has caused me great harm. I have went several years without a pay check. I believe that this was there intention. I have been denied access to local law enforcement, and medical treatment. I would like to know what court order did this, who obtained this. And if possible be compensated for their statement. I might think off pulling rotaries charitable operating license. I have been repeatedly asked to go on social outings an then pumped for details about my business and experiences working on wall street in a social and plain close environment. The local authorities have done nothing to stop this or compensate me for this damage.

I ran an entellus query on my phone number and by previous big sky mailing address. It returned two people, with almost the exact same names, but different work histories, criminal, birthdates etc. All my utilities including cell phone are billed to this address. I don't know if this guy exists, or if he has been declared mentally incompetent or has an std, but this is what might be seen when you run a records check. I have owned the condo for about 6-7 years. I live alone. I am unaware off how this person got onto my address. I believe that was the intent. Weather this persons records ware used to gain access to my email, and cell phone may have been the case. Every email I right to a government agency is simply not returned. And physical mail sent to my previous po box is simply not replied to. Any physical call I make to any body in federal or state government, simply does not go past the secretary. Including trying to schedule specialist visits with local doctors. I believe that this is a byproduct and the intent off this scam. I think it is clear that this is the intent off this second entry. To pull a random entry out off the database, and say look, look, look, this this pearson. This has all been done behind my back.

Let me also state, that if any one thinks or claims to have power off attorney or power off medical/truste, this has been done behind my back. I don't believe it to be legal or enforceable.

Criminally, I have never been in front of a judge for anything worse than traffic tickets. My mother is really my only remaining family. It was known that she is retired in California. She has admitted that someone from Bozeman rented the condo above me, they were very inquisitive about me. If she is pushed she says she doesn't remember, but it is clear that some people have pushed he to call me and see if this is still here sun, rather than look at id and finger prints that are on file.


If you push local law enforcement as to why no one responds to email, they simply don't reply. The Gmail came with my Verizon phone. I think they are well aware off this incident. The Gallatin Vally under sheriff, refuses to answer this question. He tries to tell me that the only thing I need is an

physiological evaluation at my own expense. He is rude and evasive, this has done me great harm. This shows the true caricature of the local law enforcement. The new sheriff simply refuses to take any off my calls. The true nature off the pig. They sit their and simply watch this. I don't know if they finally intended to simply say the condo is the property off the other person, and introduce him to the property management company.

I have recently applied to social security benefits. The web sight says they can be approved in 4-5 days. The claim was sent to Helena after three weeks. I was told that they will require 4-5 moths to review all the medical records. The lost transcripts, will obviously be a problem. The do this procedure behind closed doors. They refuse to disclose what or who is presented. I believe that this delay is criminal. Its intention is to cause financial hard ship. You be the judge.

Attn Judge

I filled a Pro Se General Civil Case with the court late Tuesday 1/22/2013. It was dismissed. I have refilled with the additional information that their may have been some identity problems as some else with a similar name may have tried to have had them recorded as a resident off my condo. I realize that it will take you a while to look into this. I am an American citizen by birth, have no criminal record other than traffic tickets etc and a college degree. If there was any court order involving a judge that cause some off this, I was unaware off any off the proceedings, have never been served or even told off what the proceedings were or any judgment or rulings that were made. I hope you can assist me in getting to the bottom off this and compensated me for the damage in this civil suite.

At this point, I have been refused proper medical treatment, been forced to use my own savings for support. I do own a Condo in Big Sky Montana, It has been continually vandalize, causing additional expenses. The police refuse to respond even when called. I have over the last three to four years had many electronic problem, credit cards being popped, emails fishing for address. Accounts opened in my name or phone number not by me. What ever was done, the FBI and police feel that the do not have to respond even when called. A ceo off the local hospital retired around the time off one medical review board hearing. The Gallatin county sheriff retired at about the same time as the first hearing. Transcripts have been lost or fabricated.

This has created stress, wasted allot off my time and generated a financial hardship. While you do your discovery, can you provide short term support for daily living needs. Tensions between the local police are high, I am not happy. I do not understand why they think they don't have to respond. I believe this is criminal, they just stand there and do nothing. But this is up to you and the court. Can you help with living expenses' etc while the suite works its course. I can rent an apartment in another state, and become a resident and change my drivers licenses.

What ever was done has caused my police department, my senators office, the state attorney general office and governor not to respond at all, as if I just don't exist. This is paramount to watching someone starve. Can you help. This has been going on for over two years. If nothing else, can you explain what I have done or what has done this to me. I don't believe this is correct. When I am in town. My place is like a cell, solitary confinement. People are very cold. Can you at least explain this to me. The undersheriff refused to respond, they have simply watched this. I have been approached in plain clothes. I don't know why. Can you help. Jenifer Demagic, Senator testor Aid, also refuse to respond, or tell me why she has been told not respond.

It is clear that I have been milked recently, potential in a drink, or in food. I have not knowingly ingested anything. I have sought medical attention. The doctors feel it will go away, they are very unsure or will not tell me what the drug was. It long term effects, or how long it takes to ware off. This retired doctor popped up as soon as I returned, about the time that these effect started to appear. Local law

enforcement simply could care less about how I support my self, of even how to correct any off the problems or lack off opportunities cause by this identity theft. This was done, after my return to Montana after the first version of this suit was filed and dismissed. I did inform the friendly us marshal that I met when I filed this in person back in January. I notice that we have a new head off salt lake city FBI. I was also made public knowledge that there problems found inside Microsoft email. This was my primary email at the time.

There has been some entries and say break ins in my condos. My 30,000 off Russian art was not touched, but documents like social security cards, and birth certificates, leases etc were taken. My passport which has a picture was left. I am in the process of replacing them.

Could you order monthly payment of 20,000 – 30,000 a month if you feel that it will take some time to fully resolve the issues in this suite.
