PROCEEDINGS: SCHEDULING CONFERENCE

Scheduling Conference held. Court and counsel confer re case management. Plaintiff has filed a motion for preliminary injunction. Fed. R. Civ. P. 65, provides express authority for consolidating the hearing of an application for a preliminary injunction with a trial on the merits. The parties seem to agree on the basic factual issues and the disputed issues are ones of law that will be appropriately decided by the Court. A final decision on the preliminary injunction and on the merits appears to be in the best interests of both parties, in terms of saving the costs of further litigation and eliminating the potential problems associated with a future disallowance action if the Court eventually ruled in favor of defendants after first granting a preliminary injunction. The court therefore finds that is appropriate to consolidate the hearing on the preliminary injunction with the trial on the merits pursuant to Fed. R. Civ. P. 65(a)(2).

The jury trial, final pretrial conference, motion cut-off, discovery cut-off dates and related dates were ordered by the Court as set forth in the attached Schedule of Trial and Pretrial Dates. The deputy clerk is ordered to file and serve the Court's Scheduling Order and Civil Trial Order on all parties. Because of the consolidation of the hearing on the preliminary injunction with the trial on the merits, the hearing on Plaintiff's motion for preliminary injunction, currently calendared for August 9, 2004, is vacated and the matter taken off calendar.
