1. Plaintiffs in the above entitled action have executed a civil action, pursuant Fed.R.Civ.P. Rule 3, against the defendants on Dec 30, 2013, in the ___forenoon of the day or as soon as counsel can be heard, in the room A012 of the US District Courthouse, at the US Judicial District Court of Hartford, at 450 Main Street in the Judicial District of Hartford, in Hartford, CT 06_____, on all grounds expressed and or enumerated in the cause of action of the civil case.

2. The defendants, in the above entitled action, are required to answer the Complaint within the statutes of limitation of 21 days after receiving, on or by _____, 2013 at the US District Court of Connecticut to answer said complaint. Failure to respond within the Statue of Limitation of those days will commence default judgment against all litigants in the civil action.

4. Defendants are Storage America, 71 Spencer Street, Manchester, CT 06042 and Ebay, Inc at 2145 Hamilton Avenue, San Jose, CA 95125, including 800 Marina Boulevard, Fifth Floor, Brisbane, CA 94006.

JURISDICTION

5. The US District Court of Connecticut, in the Judicial District of Hartford has Legal jurisdiction in the civil action because the property of the church which was in the storages of the plaintiffs is protect, pursuant to the First Amendment to the Constitution Of these United States, which implied and express church “Right of Sovereignty;” whereof, it prohibit and limit’s the invested powers of the Government, Legislatures and States from abridging, depriving, handcuffing, denying and or prohibiting the church rights to Sovereignty as an entity and or prohibit the limitation of church right’s to excercise redress and or petition independent legal judgment for recovery of its property(ies) and or asset(s), within the statues of limitation of the church ordinances and Its by-laws in the land(s) and or country(ies) whereof its entity(ies) are therein.

6. Title 8 USC § 1483(a) address individual sovereignty base upon heredity and or land , Title 28 USC §1391(a)(2), Title 28 USC §1369(c)(2), Fed.R.Civ.P. Rule 4 and CT G.S. sec 51-344a.

VENUE

7. Venue of civil action is within the legal scope of the law pursuant to CT G.S.

sec 52-91, CT G.S. sec 51-345, CT G.S. sec 51-346, CT G.S. sec 51-348 and CT G.S. sec 51-349.

CAUSE OF ACTION

8. Plaintiffs is suing the defendant for grand larceny in the dollar amount of 3.5 millions for properties who total net worth value was \$450,000.00, which consist of The church libraries books of rare copies of books with 24 Karate gold trimmings and coverings, copies of ancient documents, furniture, silverwares, and more; relative Properties and more: but not limited to the plaintiffs property as well, placed in the storages of 218, 193, 157 and 366, at Storage America and was confiscated by Storage America in July 2012 because the plaintiffs own them rent for four storages in the dollar amount of about \$6,000.00.

9. The defendants had knowledge, aforethought, as to the dollar value of the plaintiffs properties because Connecticut General Statute 47a-11b(d) require any landlord to do an inventory of the occupants' asset prior to disposing of it, when the occupants of the storages "allegedly abandons it and that the occupants storage and belongs can only be dispose, and or sold by the landlord base only on abandonment, Connecticut General Statute 47a-11b(a)." In the case of the plaintiffs they did not abandon their properties in the storages, which they occupied at the defendants storage company. There was payment made on the storages the month before July 10, 2012, prior to it being sold. And if there were any remaining properties of the plaintiffs left in the storages after allegedly auction, the defendants took that too.

12. Further, the plaintiffs are suing the company Ebay, the defendant, because they allow their company to be use for laundry of stolen properties by Storage America..

DAMAGES

13. Plaintiffs are suing the defendants for dollar amount of \$4.5 million in punitive and Monetary damages stolen properties that was worth more then what was owed defendant, Storage America and the defendant Ebay for laundry the plaintiffs stolen properties.




