3) PLAINTIFF HAS NOT RECEIVED A ROYALTY PAYMENT FROM EITHER AMAZON.COM, INC., OR GOOGLE.COM, INC IN SPITE OF BOTH COMPANIES READING ENORMOUS PROFIT FROM SALES OF THESE THREE (3) BOOKS GLOBALLY SINCE 2006.

4.) PLAINTIFF HAS NO CONTRACT WITH GOOGLE.COM INC OR AMAZON.COM INC AUTHORIZING UNIVERSAL SALES OF HIS COPYRIGHTED WORK.

5.) ALL THREE (3) BOOKS WERE PUBLISHED THROUGH TRAFFORD PUBLISHING COMPANY IN BLOOMINGTON INDIANA.

6.) PLAINTIFF HAS NO CONTRACT WITH TRAFFORD, PUBLISHING COMPANY AUTHORIZING SALES OF HIS BOOKS UNIVERSALLY THROUGH GOOGLE.COM INC OR AMAZON.COM INC.

7.) INTERNET SEARCHES REVEAL GOOGLE.COM INC AND AMAZON.COM INC SELLING PETITIONERS BOOKS FOR \$2,347.00, \$1,200.00, \$1,100.00, \$193.00, \$68.00, \$38.00, \$42.00 ETC.

8.) PLAINTIFF HAS NEVER AUTHORIZED ANY OF THESE SALES AND HASN'T BEEN COMPENSATED

Relief:
