FIRST CAUSE OF ACTION

(Negligence)

1. Plaintiff Adam Blumenkranz (hereinafter referred to as "Blumenkranz") is, and at all times herein mentioned was, an individual residing in the State of California, County of Los Angeles at the time of the incidents alleged herein.

2. Defendant, Facebook, (hereinafter referred to as "Facebook") is and at all times herein mentioned was a corporation residing in the State of California, at the time of the incidents alleged herein.

3. That the true names or capacities, whether individual, corporate, associate or otherwise of defendants are unknown to Plaintiff, who therefore sue said defendants by such fictitious names. Plaintiff is informed and believes and thereon alleges that each of the defendants designated herein

3 4. That at all times herein mentioned, defendants, and each of them, were the agents and/or
4 employees of each of the remaining defendants, and were at all times acting within the purpose and
5 scope of said agency and employment, and each defendant has ratified and approved the acts of his

7 5. Plaintiff is informed and believes and thereon allege that each and every of the acts and
8 omissions alleged herein were performed by and or under the direction and control of each of the
9 other Defendants, and that said acts and failures to act were within the normal course and scope of
10 said agency, employment and/or direction and control.

11 6. Plaintiff is informed and believes and thereupon alleges that, at all times relevant herein,
12 each defendant was completely dominated and controlled by his/her co-defendant and each was the
13 alter-ego of the other. Whenever and wherever reference is made in this complaint to an act by a
14 defendant or defendants, such allegations and references shall also be deemed to mean the acts and
15 failure to act of each defendant acting individually, jointly and severally. Whenever and wherever
16 reference is made to individuals who are not named as plaintiff or defendants in this complaint but
17 were employees/agents of defendant(s), such individuals, at all times relevant herein, acted on behalf
18 of defendant(s) within the scope of their employment.

19 7. Plaintiff is informed and believes and thereon alleges that a person named Larry Davis
20 posted defamatory material about Plaintiff on Facebook. Plaintiff is further informed and believes
21 and thereon alleges that Larry Davis is not the true or given name of an individual that has posted
22 false, misleading and defamatory allegations against Plaintiff on Facebook and several other public
23 forums. Larry Davis published a post to numerous blogs contained defamatory material and mis-
24 statements of truth about Plaintiff Blumenkranz. The posts to the blogs contained clear mistakes of
25 fact not investigated by Defendants, yet proffered as absolute truth, and statements that present
26 Plaintiff Blumenkranz in a false light. As a result of the above-described false statements, Plaintiff
27 Blumenkranz has suffered damages to his reputation in his profession and emotional distress in a
28 sum which is unknown to Plaintiff, but Plaintiff will amend this complaint to state the amount

1 before or at time of trial.

2 8. Plaintiff Blumenkranz complained to Facebook about the falsity of the posts. Plaintiff
3 Blumenkranz further complained that the account under the name of "Larry Davis" was a fake
4 account. Defendant Facebook failed to take any action on the complaints of Blumenkranz. In fact
5 Facebook did not respond to Plaintiff Blumenkranz at all. Plaintiff Blumenkranz contends that
6 Defendant Facebook owes a duty to Blumenkranz not to publish or republish the false statements
7 of third parties. Defendant Facebook breached its duty to Blumenkranz by not only publishing and
8 then republishing the false statements of a third party but by not responding to Blumenkranz
9 requests to remove the allegedly false account of "Larry Davis"

10 9. As a direct and proximate result of the actions of defendants, and each of them, plaintiff
11 has suffered serious emotional injury and was hurt and injured in his health, strength and activity.
12 These injuries have caused, and continue to cause, great mental, physical and nervous pain and
13 suffering, and the long-term and permanent effects of these injuries are currently unknown. As a
14 result of these injuries, plaintiff has incurred, and will incur in the future, medical expenses and has
15 suffered general damages in an amount in within the jurisdictional minimum of this court, in an
16 amount to be determined at trial.

18 **WHEREFORE**, Plaintiffs pray for judgment against Defendant's, and each of them, as
19 follows:
