Affidavit of Poverty.

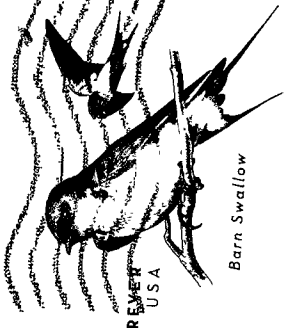
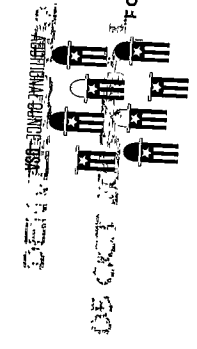

Conclusion.

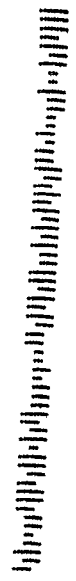

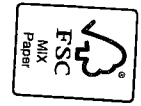
