COMPLAINT FOR A CIVIL CASE ALLEGING BREACH OF CONTRACT
(28 U.S.C. Sec. 1332; Diversity of Citizenship)

Basis for Jurisdiction

- I. Federal courts are courts of limited jurisdiction (limited power). Under 28 U.S.C. Sec. 1332, federal courts may hear cases in which a citizen of one State sues a citizen of another State or nation and the amount at stake is more than \$75,000. In that kind of case, called a diversity of citizenship case, no defendant may be a citizen of the same State as any plaintiff. Explain how these jurisdictional requirements have been met.

A. The Plaintiffs

1. Shirley M. Jackson (Shirlfox); and the Man Lewis, Jr. (Bigdog), are citizens of the State of Michigan.

B. The Defendants

1. Mike Zuckerberg is a citizen of the State of California; and Curtis Nesmith is also a citizen of the State of California.
2. Facebook is incorporated under the laws of the State of Delaware, and has its principal place of business in the State of California.

C. The Amount in Controversy

The amount in controversy-the amount the plaintiff claims the defendant owes or the amount at stake-is more than \$75,000, not counting interest and costs of court, because the amount promised was \$100,000 plus \$300,000, \$1.00 for the registration fee, and additional costs and time associated with the task performed in response to the offer, numerous downloads, and the acute mental anguish, pain and suffering of high blood pressure associated with defendants' failure to deliver.

II. Statement of Claim



Plaintiffs Shirley M. Jackson and Man Lewis, Jr., are Entertainment Performers that both have a Face Book page where they share their talent with family & friends. The Following is a link to Plaintiff Shirlfox' Facebook Page: <https://www.facebook.com/opis7>

On August 21, 2018, Facebook Notified both Plaintiffs Shirley M. Jackson (Shirlfox) and Man Lewis, Jr. (Bigdog) with an offer to win Money, but first requiring the purchase of Skyscraper Movie by Dawyne Johnson; and proof of a "Registration" which is mandated by the purchase of the movie. Plaintiff Shirley M. Jackson made such a purchase in the amount of \$1.00, and \$34.00 after five days (Ref. #0832-84-1894319042); Downloading The Movie multiple times was part of the offer. Plaintiffs received numerous offers from defendant Facebook between August 21, 2018, and August 24, 2018, but didn't win any offers, because other winners were selected. Finally we received an offer that required computer expertise Which Plaintiff Lewis had; and required speed due to

multiple downloads, and searches throughout the numerous Facebook post. On August 24th, 2018 at approximately 10:40 p.m., Plaintiffs Shirley M. Jackson (Shirlfox) and Man Lewis, Jr. (Bigdog), received a notification from the Facebook Page at <https://www.facebook.com/opis7> which opened the following link with the following written offer:

“FOR TODAY 10 HOURS FROM NOW !!! It's Official, I Give \$ 100,000 Who Likes And Share This Post!

10 Times Share 100,000  

20 Times Share 200,000  

30 Times Share 300,000  

3 Times Download a Car Gift¹⁰⁰

There are 6 unit CAR for 6 winners. !!! Please Share And Comment. Note: LOVE, SHARE, and MARK YOUR FRIENDS at this post *and it will be a winner*”

These offers were validated by Plaintiff Facebook Lottery Prize Award Dept. Winning Certificates from both Defendants’ Authorized signature in the amount of \$800,000.00; and photos of large amounts of money to be awarded the winners.

Plaintiff accepted the offer and used live recordings of their performances to promote the movie Skyscraper, and shared the post in question; downloaded the post 30 times for the \$300,000; downloaded 3 Times a Car Gift; searched and found the 6 unit Car for 6 winners; commented with love, shared over 50 times; and Marked Plaintiff’s friends Dawyne Johnson & Vin Diesel with a computer marker at the Post in question; and submitted a copy of all of the proofs to substantiate compliance with defendant’s entire offer.

Plaintiffs then contacted defendants informing them of the compliance:

“As you requested; 30 x shared; marked my friends; 3 x down loaded car gift; shared love & commented on 6 unit CAR for 6 winners; and marked my friends at this post as you requested. Please send my winnings here PayPal. Me/TheJLG”

The Plaintiffs’ have complied with the plaintiffs’ obligations under the contract.

III. Relief


WHEREFOR, Plaintiffs Shirley M. Jackson (Shirlfox) & Man Lewis, Jr. (Bigdog), respectfully request this Honorable Court assume jurisdiction of this matter; and find that defendants are liable to Plaintiffs for breach of contract in the amount promised: \$300,000, and nominal fees of \$1.00 for the registration cost; over 50 downloads, and additional costs for multiple downloads of a movie exceeding 1 hour long; and time associated with the task performed in response to the offer; and the acute mental anguish elevating high blood pressure associated with defendants’ failure to pay their offer.

IV. Certification and Closing


