The Plaintiff has good reason to believe that the described old/unused/recently confirmed hacked account (e.g. brycedavis333@yahoo.com) may be connected to the (preventable) Marines United Scandal, which grossly mirrors the Police Social Media Scandal that The Plainview Project relatively recently exposed. The Plaintiff is deeply concerned that individuals may have been harmed and wants to ensure that however many victims there are, receive the legitimate truth, justice, and closure that they all deserve.

...causing unnecessary distress to the Plaintiff due to inadequate responses to Plaintiff's genuine concerns regarding an old/unused/recently confirmed hacked email account (e.g. brycedavis333@yahoo.com). Although the Plaintiff initially thought the account was a Gmail account, and despite having not used it in years; however, Yahoo reportedly suffered a massive data breach and the Plaintiff suspects that another user may have been actively using the described account for years. Despite filing numerous reports to various agencies, the Plaintiff is still deeply concerned that some form of illegal activity may have occurred without the Plaintiff's knowledge.

#### IV. Relief

Once this information is wholly obtained, and all other related legal matters are resolved, then the Plaintiff will request for that account to immediately and permanently deleted.
