If this goes ignored, I plan to reach out to national news networks such as CNN + MSNBC to inform them of the harrasment + bullying your platform promotes. This intentional infliction has caused emotional distress, + interference with business relationships.

I am seeking damages in the amount of \$250,000 for lost wages. (The stalking + harrasment also took place at job), also because I have no secure + safe place to live, vehicle to drive due to the websites descions to allow my location to be posted.
