13 The Defendant Larnell Palmer now comes forth to bring this lawsuit to the courts
14 for relief. Plaintiff is suing Google LLC, Youtube, and Alphabet for breach of
15 contract and racial discrimination.

16 The Plaintiff Larnell Palmer went into contract with Youtube when we made an
17 account called "Mr. Palmer." Youtube requires you to agree to before signing up.

18 On September 1st the Plaintiff uploaded a video called "Father Gives Daughters Ex

19 Boyfriend That Wish A Mf Would For Trying To Break In." In this video the

20 plaintiff reacted to a video that was showed here:

Fox 9 Minneapolis in which they showed a video where a man shoots another man.

1 When the plaintiff played the Fox 9 video on his own channel (under the fair use
2 doctrine) Youtube then flagged the video for “violent or graphic content.” However
3 all the plaintiff did was react to a video that was already posted. To this day the
4 Fox 9 Minneapolis page has the exact same video up. They have not been flagged
5 and their content still remains up with over 608,000 views at the time of this
6 writing.

7 Because of this incident Youtube is breaching their contract with the creator (to
8 equally enforce its Terms of Service) and is participating in racial discrimination.

9 Mr. Palmer is an African American Youtuber who focuses mainly on men’s rights
10 and sometimes black issues. Fox 9 is a white owned corporation. Clearly Youtube
11 only wants certain demographics covering certain news stories.

12 Youtube infringed on Larnell Palmer’s right to equal treatment under the law. The
13 plaintiff asks for \$250,000 in total damages. \$2000 for the loss of income for the
14 inappropriate flagging of his channel and \$248,000 in punitive damages to
15 incentivize Youtube to apply its rules fair and square.
