



2. Pro Se Plaintiff Jerico Matias Cruz currently have two emails attached to his LinkedIn Account: techmeetvp@protonmail.com and theconsultantoo0oo@gmail.com.

3. Defendant LinkedIn Corporation's mailing address is located at 1000 W Maude Ave, Sunnyvale, CA 94085.

4. Defendant LinkedIn Corporation's mailing address of its registered agent will be used as a secondary mailing address for this civil action, which is currently located at [1505 Corporation 538 Corporation Service Company which will do business in State of California as] CSC - Lawyers Incorporating Service, 2710 Gateway Oaks Dr, Ste 150N, Sacramento, CA 95833.

5. Pro Se Plaintiff Jerico Matias Cruz files a complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's terms and conditions against Defendant LinkedIn Corporation for punitive damages and restitution pursuant to 47 U.S. Code Section 230.

#### **BACKGROUND**

6. On or about December 2012, pro se Plaintiff Jerico Matias Cruz signs up with Defendant LinkedIn Corporation by electronically agreeing with the user agreement, professional community policies, and other user agreements or policies that are not included with prima facie evidence and material facts

presented and attached to the exhibits of this civil action. *See* Exhibit A about Defendant LinkedIn Corporation's user agreement and professional community policies.

7. On or about January 2023, pro se Plaintiff Jerico Matias Cruz compiles all the emails received from Defendant LinkedIn Corporation between January 2022 and January 2023. *See* Exhibit C about pro se Plaintiff Jerico Matias Cruz's emails received from Defendant LinkedIn Corporation between January 2022 and January 2023.

8. On or about January 2023, pro se Plaintiff Jerico Matias Cruz receives multiple temporary restrictions from Defendant LinkedIn Corporation for verifying pro se Plaintiff Jerico Matias Cruz's identity. *See* Exhibit B about the emails received from Defendant LinkedIn Corporation for providing and validating pro se Plaintiff Jerico Matias Cruz's identity.

9. On or about January 2023, pro se Plaintiff Jerico Matias Cruz verifies his LinkedIn account by providing a copy of Illinois Driver's License front and back card using the .jpeg format; and pro se Plaintiff Jerico Matias Cruz also provides his Cook County Military and Veterans Discount Card, which is issued by the Cook County Recorder of Deeds - Veterans Services.

**STANDARD OF REVIEW**

10. The United States District Court for the Northern District of Illinois, Eastern Division operates under the United States Constitution, the United States Code, Code of Federal Regulations, Public Laws, the United States President's Executive Orders, the United States Supreme Court Rules, and Federal Rules of Evidence.

11. Civil proceeding enacted upon the codified rules of Federal Rules of Civil Procedure. *See* Clark and Moore, *A New Federal Civil Procedure-I. The Background*, 44 Yale L.J. 387, 391 (1935). (28 U.S. Code Section 723(b); 28 U.S. Code Section 723(c); 28 U.S. Code Section 1343; 28 U.S. Code Section 1367; 28 U.S. Code Section 2072)

12. Civil proceedings also follow the codified rules of Local Rules of the United States District Court for the Northern District Court of Illinois, Eastern Division.

13. The United States District Court for the Northern District of Illinois, Eastern Division adjudicates prima facie evidence and material facts in accordance with *pro se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's user agreement and professional community policies and other user agreements or policies not listed or attached to this civil action. Defendant LinkedIn Corporation shall be held accountable to answer *pro se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's user agreement and

professional community policies and other user agreements or policies not listed or attached to this civil action after issuance of summons within twenty-one (21) days, excluding federal legal holidays, Saturdays and Sundays. Any responsive federal statutes or laws should be applied when the United States District Court for the Northern District of Illinois cross-examines prima facie evidence and material facts by following Federal Rules of Civil Procedure, Federal Rules of Evidence, and Local Rules of the United States District Court for the Northern District of Illinois, Eastern Division during Civil proceedings.

14. Pursuant to Federal Rules of Civil Procedure and Local Rules of the United States District Court for the Northern District of Illinois, Eastern Division, *pro se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's user agreement and professional community policies and other user agreements or policies not listed or attached to this civil action follows the codified rules of Federal Rules of Civil Procedure and Local Rules of the United States District Court for the Northern District of Illinois, Eastern Division when adjudicating the United States District Court for the Northern District of Illinois, Eastern Division's federal Civil cases, including 47 U.S. Code Section 230.

15. *Pro Se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's user agreement and professional community policies and other user agreements or policies not listed or attached to this civil action is filed on proper venue.

16. *Pro Se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's user agreement and professional community policies and other user agreements or policies not listed or attached to this civil action is lawfully dealt with subject matter jurisdiction and personal jurisdiction.

17. *Pro Se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's user agreement and professional community policies and other user agreements or policies not listed or attached to this civil action is constructed simply and conservatively and guided by Federal Rules of Civil Procedure and Local Rules of the United States District Court for the Northern District of Illinois, Eastern Division.

18. *Pro Se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and

breach of contract with Defendant LinkedIn Corporation's user agreement and professional community policies and other user agreements or policies not listed or attached to this civil action enumerates a list of material facts that have been photographed, photocopied, audio recorded, and/or video recorded, and such that material facts and prima facie evidence from *pro se* Plaintiff Jerico Matias Cruz's complaint's Exhibits; and other material facts and prima facie evidence related to *pro se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's user agreement and professional community policies and other user agreements or policies not listed or attached to this civil action.

19. Honorable Court allows to grant *pro se* Plaintiff Jerico Matias Cruz to use the power of subpoena and expert witness only if necessary during the cross-examination of prima facie evidence, material facts, and testimonies presented before the court.

20. *Pro Se* Plaintiff Jerico Matias Cruz and Defendant LinkedIn Corporation has an authority to answer to discovery, interrogatories, and/or depositions during the discovery at a later date and time through oral and/or written motions and/or petitions.

21. Any additional material facts and prima facie evidence attached to *pro se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's user agreement and professional community policies and other user agreements or policies not listed or attached to this civil action are considered Exhibits and/or Affidavits that can be used during cross-examination.

22. Previous adjudicated federal civil cases relevant to *pro se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's user agreement and professional community policies and other user agreements or policies not listed or attached to this civil action could be cited and/or mentioned on written statement and/or oral argument for cross-examination of prima facie evidence and material facts with respect to Federal Rules of Civil Procedure and Local Rules of the United States District Court for the Northern District of Illinois, Eastern Division.

23. *Pro Se* Plaintiff Jerico Matias Cruz and Defendant LinkedIn Corporation have a liberty to present previous federal Civil cases within written statements and/or oral arguments without violating the codified rules of Federal Rules of Civil



Procedure and Local Rules of the United States District Court for the Northern District of Illinois, Eastern Division.

24. Any violation of Federal Rules of Civil Procedure and Local Rules of the United States District Court for the Northern District of Illinois, Eastern Division cannot be waived and be granted by the United States District Court for the Northern District of Illinois, judge, presiding, and therefore, *pro se* Plaintiff Jerico Matias Cruz's complaint for violation of constitutional rights in particular with first amendment and freedom of expression online and breach of contract with Defendant LinkedIn Corporation's user agreement and professional community policies and other user agreements or policies not listed or attached to this civil action is subject to dismissal ditto to Defendant LinkedIn Corporation.

### **ARGUMENT**

**Count I: Defendant LinkedIn Corporation has a greater control of pro se Plaintiff Jerico Matias Cruz's LinkedIn account and contents, which illegally block and screen materials that are not offensive in the professional network platform pursuant to 47 U.S. Code Section 230(a)(2).**

35. Pro Se Plaintiff Jerico Matias Cruz's LinkedIn account is privately blocked and screened by Defendant LinkedIn Corporation without properly explaining the problem. However, Defendant LinkedIn Corporation asks for government-issued photo identification to verify if the LinkedIn account belongs to pro se Plaintiff Jerico Matias

Cruz. Pro Se Plaintiff Jerico Matias Cruz provides two different government-issued photo identification to recover his LinkedIn account: Illinois Driver's License card front and back and Cook County Military and Veterans Discount card. Pro Se Plaintiff Jerico Matias Cruz does not violate Defendant LinkedIn Corporation's User Agreement Section 8.2(1). Pro Se Plaintiff Jerico Matias Cruz is the rightful owner of this LinkedIn Account for more than a decade and has invested into this LinkedIn account, such as networking events, professional networking events, and other networking events that involve in-person networking events. Pro Se Plaintiff Jerico Matias Cruz's LinkedIn account is not a false identity in the professional networking platform of Defendant LinkedIn Corporation. Defendant LinkedIn Corporation simply violates Section 230(a)(2).

“These services offer users a great degree of control over the information that they receive, as well as the potential for even greater control in the future as technology develops.” 47 U.S. Code Section 230(a)(2).

**Count II: Pro Se Plaintiff Jerico Matias Cruz uses Defendant LinkedIn Corporation's professional networking platform to link and connect with professionals, and not to stalk and harass other users, and post obscenes contents with other users pursuant to 47 U.S. Code Section 230(b)(5).**

36. Pro Se Plaintiff Jerico Matias Cruz uses Defendant LinkedIn Corporation to promote his newly published book entitled “On Politics of 21st Century First Edition”. Pro Se Plaintiff Jerico Matias Cruz is the original author of On Politics of

21st Century First Edition. On Politics of 21st Century First Edition is now available in marketplace, such as Amazon.com. Pro Se Plaintiff Jerico Matias Cruz is promoting On Politics of 21st Century First Edition in Defendant LinkedIn Corporation's professional networking platform. Defendant LinkedIn Corporation privately blocks and screens pro se Plaintiff Jerico Matias Cruz's promotions and advertisements of On Politics of 21st Century First Edition.

"It is the policy of the United States to ensure vigorous enforcement of Federal criminal laws to deter and punish trafficking in obscenity, stalking, and harassment by means of computer." 47 U.S. Code Section 230(b)(5).

**Count III: Defendant LinkedIn Corporation shall not treat pro se Plaintiff Jerico Matias Cruz as a publisher or speaker of any information provided by another information content provider pursuant to 47 U.S. Code Section 230(c)(1).**

37. Pro Se Plaintiff Jerico Matias Cruz strictly follows Defendant LinkedIn Corporation's professional networking platform's user agreement and professional community policies. Pursuant to Section 230(c)(1), Defendant LinkedIn Corporation cannot treat pro se Plaintiff Jerico Matias Cruz as a publisher or speaker of another content provider because pro se Plaintiff Jerico Matias Cruz is only promoting and advertising On Politics of 21st Century First Edition.

"No provider or user of an interactive computer service shall be treated as the publisher or speaker of any information provided by another information content provider." 47 U.S. Code Section 230(c)(1).

### **CONCLUSION**

WHEREFORE, *pro se* Plaintiff Jerico Matias Cruz prays to the Honorable Court to grant the relief:

- (1) Issue an order to remove the temporary block of *pro se* Plaintiff Jerico Matias Cruz's LinkedIn account for more than a decade;
- (2) Issue an order for punitive damages against Defendant LinkedIn Corporation.;
- (3) Issue an order for a restitution for blocking and restricting *pro se* Plaintiff Jerico Matias Cruz's LinkedIn account; and
- (4) Issue an order for such declaratory, or other relief as may be appropriate, including attorney's fees and reasonable expenses only if *pro se* Plaintiff Jerico Matias Cruz allows to be represented by a third-party law firm or independent attorney for this specific case.
