1 Pursuant to Rule 41(a)(1) of the Federal Rules of Civil Procedure, Plaintiff
2 Thomas Robins (“Plaintiff”) and Defendant Spokeo, Inc. (“Spokeo”) (collectively,
3 the “Parties”), by and through their respective counsel of record, hereby stipulate as
4 follows:

5 WHEREAS, Spokeo denies Plaintiff’s allegations and denies any wrongdoing
6 or liability to Plaintiff or any other member of the putative classes identified in
7 Plaintiff’s complaints;

8 WHEREAS, in the interest of avoiding the expense and disruption of
9 additional litigation, the Parties have agreed to settle this litigation;

10 WHEREAS, with the Parties’ settlement agreement in place and the steps that
11 Spokeo has taken in response to the allegations in this lawsuit or agreed to undertake
12 as a result of the settlement agreement, Plaintiff and his counsel at Edelson PC have
13 concluded that Spokeo currently is not in violation of the Fair Credit Reporting Act;

14 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by
15 and between the Parties, that Plaintiff’s individual claims asserted in this action are
16 hereby dismissed with prejudice and any claims of the putative class are hereby
17 dismissed without prejudice.
