RE: Subpoena pursuant to Digital Millennium Copyright Act, 17 U.S.C. § 512(h)

Dear Sir or Madam:

On behalf of our client Rangers International Football Club, plc, I respectfully request that the Clerk of the Court issue the attached subpoena to Scribd, Inc. pursuant to the Digital Millennium Copyright Act ("DMCA").

Section 512(h) of the DMCA provides that a "copyright owner or a person authorized to act on the owner's behalf may request the clerk of any United States district court to issue a subpoena to a service provider for identification of an alleged infringer . . ." 17 U.S.C. § 512(h)(1). Pursuant to Section 512(h)(2), a subpoena request must include:

- (1) a copy of a notification of claimed infringement described in Section 512(c)(3)(A) of the DMCA;
- (2) a proposed subpoena; and
- (3) a sworn declaration to the effect that the purpose for which the subpoena is sought is to obtain the identity of an alleged infringer and that such information will only be used for the purpose of protecting rights under Title 17 of the United States Code.

These documents are attached to this letter.
