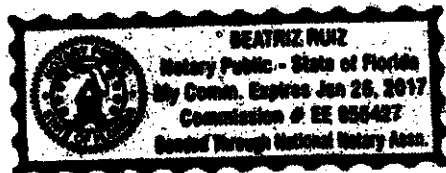
Before me, the undersigned authority, personally appeared Lorena Colombo, who is personally known to me, and after being duly sworn, stated:
