**ORDER GRANTING PERMANENT INJUNCTION**

THIS CAUSE came on to be heard upon Plaintiff, INGA KHACHATUROVA, M.D. (DR. KHACHATUROVA), Complaint seeking an Injunction to enjoin Defendant, SHAUN PATRICK ROURKE. ("Defendant"); from the ongoing publication of false and defamatory statements; and from tortiously interfering with Dr. Khachaturova's business relationships. The court has reviewed Plaintiff's Verified Complaint, and other submissions of the Plaintiff. On December 9, 2015, the Court conducted a hearing on the Complaint at which time it further reviewed the pleadings and heard argument of counsel.

Thus, being fully advised in the premises, the Court makes the following findings of fact and conclusions of law, which findings are the reason for the entry of this injunction:

1. As detailed below, Defendant has posted false and defamatory statements about Dr. Khachaturova on an Internet post. The posting is found at: theDirty.com, <http://thedirty.com/gossip/orlando/dr-inga-khachaturova-certified-married-soon-divorced-whore/>.
2. Defendant is a resident of Orange County, Florida and subject to the jurisdiction of the Court.

3. Plaintiff has identified Defendant as the original publisher of the defamatory content, however, due to federal statutes, i.e., the Electronic Communications Privacy Act, the owner of the identified web posting service is unwilling to remove the defamatory content without a court order.

4. The above defined post, including the headline, is false and defamatory and the attached photos cast Plaintiff in a false and negative light.

5. The evidence introduced at the hearing made clear to this Court that Defendant's post is false and defamatory.

6. Among the false and defamatory statements about Dr. Khachaturova in Defendant's post are the false, defamatory, and/or per se defamatory accusations stated in the headline that: "DR. KHACHATUROVA IS CRAZY" and includes the following content: "Nik, this crazy bitch Dr. Inga Khachaturova, sleeps all over town sending everyone and anyone "sexy" pictures. She is married well now soon to be divorced and she loves dragging people through sh\*t. She also works a robot for Orlando Health and if you are lucky enough to be f\*cking her during one of these shifts, you can help her break HIPPA LAWS!!!! She is a royal piece of sh\*t who treats everyone like garbage based off of her income. I have attached a few public photos for you to share with the world."

7. The photos contained within the post place the Plaintiff in a false and negative light. See Post attached as Exhibit "A".

8. This Court expressly finds that, although irreparable injury is presumed, Dr. Khachaturova has nonetheless demonstrated that irreparable injury exists and will continue if the post is not taken down.

9. This Court finds that there is no adequate remedy at law in that the continued publication

of these false and defamatory statements are causing and will continue to cause significant and irreparable injury to Dr. Khachaturova that cannot be remedied through the repayment of money.

10. Based upon the evidence presented, Dr. Khachaturova has established that she is entitled to a judgment in her favor and against the defendant.

11. This Court has jurisdiction over this matter.

12. Based on the reasons and findings set out above, the Court further finds that Plaintiff: has a clear legal right to relief sought; no adequate remedy at law; irreparable harm; and the public interest will not be disserved by the grant of injunctive relief. Accordingly, injunctive relief is appropriate.

Accordingly, it is hereby

ORDERED and ADJUDGED as follows:

A. The Plaintiff's Motion for Injunction is hereby GRANTED.

B. Any electronic communication provider or electronic bulletin board system facilitating the dissemination of the defamatory statement, shall remove from publication the above referenced false and defamatory post found at the above listed domain within fifteen (15) days of receipt of this Order.

C. This Court reserves jurisdiction to enforce, modify or dissolve the terms and conditions of this Order and the additional relief sought in Plaintiff's complaint.

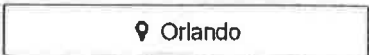
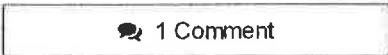
